- **Resolution #1578:** motion to enter into a contract with Decker Construction to repave the township community center parking lot not to exceed \$41,000.00 by Mr. Conroy, seconded by Mr. Jordan.

State Representative

State Representative Dorothy Pelanda spoke about two bills she is sponsoring in the Ohio State legislature. Both bills, if enacted, would provide townships with the ability to apply for grants through the Department of Commerce, one for the removal of trailers and the other for repair and maintenance of township cemeteries.

Zoning

Zoning Administratror

Mr. Honsey submitted the Zoning Administrator's report for March.

Davisson Property

Mr. Honsey reported there was a public hearing in the Union County Court of Common Pleas on March 17 for violations on the property at 12140 Watkins Road. Judge Frasier conducted a site visit on the day of the hearing. According to Mr. Honsey, the judge stated if he had to rule that day, he would find the defendant in contempt. The hearing will be continued on April 25 and Judge Frasier will make another site visit to the property prior to that date.

There has been discussion about updating the Millcreek Township Landuse/Growth Plan.

Trustees

Mr. Lynch

- The draft of Rules and Regulations for cemeteries in Millcreek Township prepared by Mr. Lynch was discussed. Recommendations were made for some modifications to the document. A vote to adopt the Rules and Regulations for cemeteries in Millcreek Township was postponed until the document is reviewed by the Union County Prosecutor's Office.
- Mr. Lynch will get the trash cans out onto the park and ball field grounds.

Mr. Conroy

- US 33 Corridor the Crossroads Area Plan for the US 33/Route 161 area was presented.
- The port a john has been delivered to the park area.
- The levy for the public safety officer, PSO, was discussed.

Mr. Jordan

- A new water pressure switch was installed in the township building in March.
- Mr. Jordan presented a second bid for replacing the ball field lights at 10420 Watkins Road ball field. The bid from Eubanks Electric for replacing the ball field lights is \$24,972.00. A bid from Area Energy & Electric was received in March in the amount of \$22,827.00. Shelley Materials purchased the original ball field lights. They have requested permission to take the light poles.
- **Resolution #1580:** motion based on reviewing the two bids to replace the ball field lights, the township trustees have decided not to replace the lights at this time by Mr. Lynch, seconded by Mr. Jordan.
- Motion unanimously approved.
- **Resolution #1581:** motion to authorize Area Energy & Electric to disconnect the electric to the ball field light bases, cap the bases, and certify the existing bases are safe and unusable by Mr. Lynch, seconded by Mr. Jordan.
- Motion unanimously approved.

- **Resolution #1582:** motion to authorize Shelley Materials to remove the existing light and poles at no cost to the township by Mr. Lynch, seconded by Mr. Jordan.
- Motion unanimously approved.

Other

- The trustees duly noted the check sequence from the previous month ending with check #4392 and checks presented for approval at the current meeting beginning with check #4393. The trustees compared the accuracy of the expenditures/electronic fund withdrawals and receipts to those listed in the minutes.
- **Resolution #1583:** motion to approve the bank statement and bank reconciliation by Mr. Lynch, seconded by Mr. Conroy.
- Motion unanimously approved.
