Millcreek Township Trustees Regular Meeting Minutes August 3, 2020

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:25 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Receipts

Meeting Minutes

Mr. Conroy asked for a motion to approve the meeting minutes from July 6, 2020.

- **Resolution #2082:** motion to approve the minutes of the July 6, 2020 meeting by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.

Jerome Township Fire Department

- Chief Stewart presented the monthly fire/EMS run stats. Response activity has been relatively consistent recently and also compared to last year.
- Chief Stewart reported that Jerome Township is moving forward with placing a fire levy on the November 2020 ballot. The Jerome Township fire levy will combine the renewal of a 2011 2.9 mill levy and ask for approval of an additional 2.9 mill levy.
- A firefighter recently resigned from the department. They are actively trying to fill the open position.

Sheriff's Report

- Deputy Davis stated he was not aware of any recent policing activity or trends that should be reported to the trustees or community, but he was open to answering any questions.
- The Trustees discussed with Deputy Davis a vehicle theft that occurred at a residence along Watkins California Road in July. The vehicle was recovered by the Columbus Police Department.
- A township resident reported to a Trustee seeing large vehicles at the township cemetery recently. The Trustees asked the Sheriff's Office to monitor and follow-up on any unusual activity at the cemetery.

Citizen Comments

• Tony Eufinger introduced himself. He provided some general information regarding work being done on the Mill Creek Log Jam Project. Tony will follow-up with Emmett Phelan with the Union County Soil & Water Conservation District to request a more detailed update be provided to the Trustees. Tony also stated he was running for Union County Commissioner on the November 2020 ballot and discussed his priorities for the county if elected.

- Township Hall rental waiver form The waiver form language was updated after feedback received during last month's meeting and assistance from Thayne Gray, Union County Assistant Prosecuting Attorney. The waiver form is ready to use for future rentals.
- Gas Line update It is expected the Ohio Power Siting Board will approve a natural gas pipeline extension to the City of Marysville (the "Marysville Connector" project) during a scheduled meeting in August.
- Township Hall internet service Internet service to the township hall was disrupted for a brief time in late July due to a billing issue. This was resolved and service is working as expected.
- Drainage tie-in request The Trustees reviewed a request to replace drainage tile within the township hall property to improve drainage east of the township property near the playground. The Trustees agreed to gather more information regarding options and costs and will discuss further at a future meeting.

Other

Heritage Cooperative is offering a prepay program to lock in the price of propane from October 1, 2020 to April 30, 2021 at \$1.139 per gallon.

- **Resolution #2085:** motion to purchase 1,400 gallons of propane at \$1.139/gallon through Heritage Cooperative's prepay program by Mr. Conroy, seconded by Mr. Jordan.
- Motion unanimously approved.

The trustees duly noted the check sequence from the previous month ending with check #5375 and checks presented for approval at the current meeting beginning with check #5376. The trustees compared the accuracy of the expenditures/electronic fund withdrawals and receipts to those listed in the minutes.

The trustees attested to the payment of the bills. The fiscal officer certified funds are available for the payment of the bills which were presented and approved by the trustees.
