Millcreek Township Trustees Regular Meeting Minutes February 1, 2021

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:20 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from January 4, 2021.

Jerome Township Fire Department

Chief Stewart presented the monthly fire/EMS stats for the month.

- Fire & EMS responses were comparable to this time last year. No noteworthy activity.
- The department utilized CARES Act funding to purchase a bariatric cot. This expands the capabilities of the department when responding to bariatric patients.
- Chief Stewart expects to present the 2020 Annual Report at the March meeting.

<u>Sheriff's Report</u>

Deputy Payton stated he was not aware of any specific issues in the township to report but was open to any questions from the trustees or the public. They continue to monitor traffic activity in the area, especially along US 42.

Public Comment

Mr. Jeff Pieper asked some follow-up questions to the trustees after attending the public hearing in January in which the rezoning of additional acreage for excavating by Shelly Materials was approved. Mr. Pieper noted some concerns he had about continued expansion of excavating operations by Shelly Materials as well as traffic activity near the quarry.

Zoning Commission

The Zoning Commission held the 2021 organization meeting on January 19, 2021.

Board of Zoning Appeals

The Board of Zoning Appeals did not meet in January. The date for the 2021 organization meeting should be determined soon, hopefully to be held in February or March.

Zoning Administrator

Mr. Ron Todd emailed the Zoning Administrator report to the Trustees for review prior to the meeting. Mr. Todd was not able to attend due to a scheduling conflict and the inclement weather.

The trustees discussed scheduling a special meeting to provide Mr. Todd an employee performance review for his role as Zoning Administrator. This was previously planned for February 1st but had to be canceled due to scheduling conflicts.

Northern Columbus Loop Gas Pipeline Project

Columbia Gas of Ohio is proposing a pipeline project referred to as the Northern Columbus Loop Pipeline Project which if approved will pass through portions of Millcreek Township.

- Mr. Thayne Gray, Assistant Prosecuting Attorney for Union County, previously emailed background information to the trustees regarding this project which will provide transmission of natural gas to areas north and west of Columbus including Union County. The trustees were also made aware of Columbia Gas of Ohio's application filed with the Ohio Power Siting Board regarding this pipeline project.
- In order for Millcreek Township to have the opportunity to engage directly in discussions on the proposed pipeline, Mr. Gray advised the trustees to pass a resolution that would allow access to the discussion.
- **Resolution #2143:** motion approving intervention in the matter of Columbia Gas of Ohio's Application for a Certificate of Environmental Compatibility and Public Need for the Construction of the Northern Columbus Loop Phase VII, before the Ohio Power Siting Board, Case No. 20-12362-GA-BTX on behalf of Millcreek Township, Union County, Ohio by Mr. Long, seconded by Mr. Jordan.

- Mill Creek Log Jam Project Discussions are being held with potential contractors. Information will continue to be gathered as the bidding process progresses.
- Trails & Greenway Committee Working groups are formed. Funding is a priority being discussed now.

- PSO Program Update Jerome Township approved adding a 5th PSO Officer and a School Resource Officer (SRO) during their January meeting. The new contract would begin July 1st.
- Website Update Mr. Conroy will talk with Georgia about making some updates to information on the township website.
- Gas Line Update No updates on the Marysville Connector Project.

• Township Hall Drainage Project – Work has not started yet. Cory has taken measurements and will be in touch to schedule the work.

Other Business Items

Special Revenue Fund

The Union County Commissioners adopted permissive county motor vehicle taxes in November 2019. These taxes began to be imposed on vehicle registrations in 2021. A portion of these taxes are to be distributed to townships. This township revenue requires the establishment of a special fund.

- **Resolution #2144:** motion to establish a special revenue fund for distribution of permissive motor vehicle tax proceeds, which shall be identified as Fund No. 2231, Permissive Motor Vehicle by Mr. Long, seconded by Mr. Jordan.
