Millcreek Township Trustees Regular Meeting Minutes July 6, 2020

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:20 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Business

Mr. Conroy asked for a motion to approve the meeting minutes from June 1, 2020.

- **Resolution #2073:** motion to approve the minutes of the June 1, 2020 meeting by Mr. Jordan, seconded by Mr. Long
- Motion unanimously approved.

Jerome Township Fire Department

- Chief Stewart presented the monthly fire/EMS run stats.
- The department responded to multiple structure fires over the past month.
- Chief Stewart will email COVID-19 case number updates to the group after the meeting. Overall, case numbers continue to increase but no significant surge of reported cases has occurred in Union County.
- Jerome Township scheduled a Special Meeting on Tuesday, July 7th to discuss the Fire Department and the possibility of a fire levy to be placed on a future ballot.

Sheriff's Report

- Deputy Smith stated he was not aware of any recent policing activity or trends that should be reported to the trustees or community, but he was open to answering any questions.
- Deputy Smith noted that Deputy Myers is taking a day-shift job within the Sheriff's Office.

Zoning

Zoning Commission

- The June Zoning Commission meeting was canceled.
- Work continues by Community Planning Insights to review overlay district language relating to the US-33 and US-42 corridors. An estimated 25% of the initial work is complete. Progress will continue during July.

Board of Zoning Appeals

- No meeting held.
- Two preliminary submittals were received and are being reviewed. No meeting to discuss either submittal has been scheduled yet though.

Zoning Administrator

Mr. Ron Todd emailed the Zoning Administrator report to the Trustees for review prior to the meeting.

- **Resolution #2074:** motion to accept the Zoning Administrator's report for June 2020 by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.
- iWorQ update: Parcel and GIS mapping is ongoing for every property in the township. Document scanning will occur after mapping is complete.
- Davisson property update: Follow-up is occurring with the property owner and the Union County Engineer on open items from the annual inspection.
- Code enforcement notices were sent to a few residents regarding trash, tall grass and vehicles parked in the right-of-way.

Township Hall Rentals – Waiver Form

Mr. Thayne Gray, Union County Assistant Prosecuting Attorney, and the Trustees discussed whether signed liability waiver forms should be required for future township hall rentals in response to the COVID-19 pandemic. Specific language necessary to include in a waiver form as well as who the appropriate signers should be were also discussed. The Trustees agreed to continue working with Mr. Gray on drafting language to include in a separate waiver form or to include within the township rental agreement for use in future township hall rentals.

Columbia Gas Marysville Extension Project

- **Resolution #2075:** motion to move into executive session to discuss the Columbia Gas Marysville Extension by Mr. Jordan, seconded by Mr. Long.

- **Resolution #2076:** motion to return to regular session by Mr. Jordan, seconded by Mr. Long.

- Mr. Gray provided an update on progress made with Columbia Gas and Ohio Gas Access Partnership (OGAP) regarding a natural gas pipeline project to the City of Marysville and a related proposed settlement agreement. The pipeline project will pass through portions of Millcreek Township. In January, the Trustees approved a motion to intervene in the Columbia Gas matter before the Ohio Power Siting Board in order to have the opportunity to engage directly in discussions. Registered "interveners" are now asked to withdraw comments and not oppose the Marysville Extension project as part of the settlement discussions. Mr. Gray can complete the necessary legal documents for the township related to this matter if authorized.
- Resolution #2077: motion to authorize Mr. Thayne Gray to sign on behalf of Millcreek Township in regards to the Columbia Gas matter before the Ohio Power Siting Board by Mr. Long, seconded by Mr. Jordan.

The Trustees discussed whether any expenditures this year would meet the required guidelines of the CARES Act. It was determined the township would not likely incur these types of expenditures. Therefore, no resolution to apply for funding will be brought forward.

The trustees compared the accuracy of the expenditures/electronic fund withdrawals and receipts to those listed in the minutes.
