## Millcreek Township Trustees Regular Meeting Minutes October 1, 2012

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:50 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Lynch called the meeting to order with the following members present:

Several residents voiced concern over gunfire in the township and asked if there were regulations for gunfire.

- Sheriff Patton answered questions stating there are no regulations for gunfire and there are no laws prohibiting shooting weapons.
- Sheriff Patton strongly urged residents to contact the Sheriff's Department when they hear several rounds of gunfire.
- Deputies dispatched to the site will determine if those involved have permission to be on the property, if they are shooting at a safe distance, if there is safe backstop substantial enough to stop the bullets, and if the guns being fired are legal weapons.

- Hardin County Monument began work restoring monuments in Watkins Cemetery.

#### Mr. Conroy

- Mr. Conroy attended the Union County comprehensive plan meeting.
- Paul Rice, legal counsel for Shelly Materials, updated Mr. Conroy on the soccer fields on Watkins Road. Mr. Rice met with representatives from the soccer club and informed them Shelly Materials will donate the gravel for the driveway and parking area for the soccer fields.

#### Mr. Jordan

• Mr. Jordan stated the lock on one set of front doors to the township building are damaged. The door locks will be repaired this week.

#### Other
