Ms. Tangeman has provided a draft copy of the Planned Residential District and Landscaping Standards for the group to review. A line by line review of the proposed landscape section for planned developments was conducted. The following is a summary of the meeting.

- 1) SECTION 13.2 Certificate of zoning compliance- Twp does not issue these. Delete reference.
- 2) SECTION 13.3 Opacity- definition or standard needed for enforcement, further research to be done by Jill Tangeman and presented to the group at a later date.
- 3) SECTION 13.3, Pg. 2 Delete <u>Junkyard and landfill statement</u>, not a permitted use.
- 4) SECTION 13.3, Pg. 3 Chart language corrected.
- 5) SECTION 13.3, Pg. 5 #8 -discussion over tree planting areas, min. sq ft., % of parking lot landscaped, (further research needed to settle).
- 6) SECTION 13.3, Pg. 6 #10 -discussion on removal and replacement requirements for trees, replacement ratios, drip line definition, keystone trees.
- 7) SECTION 13.3, Pg. 7 # 10 PID change 2.00 sq ft to 200 sq ft.
- 8) SECTION 13.4, Pg. 8 Same genus and species (not acceptable).
- 9) SECTION 13.4, Pg. 9 -Define tree lawn.
- 10) SECTION 13.4, Pg. 9 2" min Dia. (language change desired).
- 11) SECTION 13.5, Pg. 10 d. -suggest slope of 3:1 for mounds.
- 12) SECTION 13.6, Pg. 10 3b Twp. Does not issue occupancy Permit, no enforcement power by Twp for this, change wording or have county agreement, performance bond language discussed but not settled.
- 13) Punctuation and misspellings were also addressed.
