Minutes Review / Approval (Continued):

11/17/2009 Public Hearing re: M-2 Manufacturing District -

- Jim Lawrenze asked about the intention of Shelly in relation to the permitted and conditional uses in the new language. Keith Conroy responded that Shelly has sent representatives before the Trustees to request new M-2 language on at least three different occasions so that Shelly could make application to the BZA. An application was submitted to the BZA several months ago but the language was not ready. The Trustees held their public hearing on the proposed language and it was approved. Shelly has heard the public concerns about debris and toxic uses and is in the process of revising the application. The BZA will review the matter as appropriate.
- Greg Wisniewski noted that "no" on the first page, 3rd line should be "not". The change was made.
- Freeman Troyer recommended the word "omitted" be substituted for "leave from" on the last bullet point on the 4th page. The change was made.
- Motion to approve as amended by Freeman Troyer. Greg Wisniewski seconded the motion. All members voted in favor of the motion and the motion carried.

Trustee Comments

Bill Lynch reported that at their January meeting, the Trustees renewed the appointment for Greg Wisniewski through 2/15/2010.

Mr. Lynch also informed the Commission that the Trustees approved the Land Use Growth Plan Amendment. Keith Conroy thanked everyone for their efforts and time during the process. He stressed how important it was to get the public input from the Bayly Pointe discussions incorporated into the comprehensive plan for the Township.

Bill Lynch announced that the in January the Trustees interviewed several candidates for the Zoning Administrator position. There were several well qualified candidates. Joe Clase was selected as the new Zoning Administrator. He will work approximately 18 – 30 hours each month and begin February 1, 2010. Kenny Coakley has done a fine job assisting the Trustees during the interim of no Zoning Administrator and was thanked for his service.

Keith Conroy commented that Mr. Clase has prior experience with Union and Delaware County officials. He is very enthusiastic and prepared to begin his new role with the Township.
