MINUTES: Joni Orders noted that she would be e-mailing minutes to members for review and approval at the next regular meeting, since the Township copier is not working. After discussion it was confirmed that a special workshop meeting was held and that no regular meeting was held due to a lack of business.

CITIZEN COMMENTS: None.

TRUSTEES' COMMENTS: Bill Lynch introduced Joe Clase as the Township's new Zoning Administrator. Joe Clase invited members to let him know if they wanted to meet one-on-one and discuss expectations or to just give him orientation to the Township. He noted that he has sat down with Chair Joni Orders and looks forward to getting to know other members of the Zoning Commission and working with the group.

ZONING ADMINISTRATOR'S REPORT / COMMENTS: Joe Clase stated that he will be e-mailing his report to the Board of Trustees, Fiscal Officer, Zoning Commission and Board of Trustees on a monthly basis. He stated much of his first month has been orientation.

OLD BUSINESS:

- 1. Upcoming Revisions: Joni Orders thanked members for being prepared and working with Jill Tangeman. She noted there is a need to revise Appendix B. Signs was left out when the printed copies were made in 2006. She noted, it has been recommended that we reformat while reviewing and voting on this on again for inclusion. She asked that Joe Clase look at the M-1 zoning district in the next couple months and bring it in line with the new M-2 district.
- 2. Accessory Buildings: Jim Lawrenz asked if accessory buildings met county standards. Joni Orders stated the permit guidelines by size are in line with county guidelines. This was changed in May 2008 and directly references the Union County Engineer's standards should be followed.

NEW BUSINESS:

1. Wind Turbines/Solar Panels: Bill Lynch stated that wind turbines need addressed in the Zoning Resolution. Jenny Snapp with Logan, Union, Champaign (LUC) Regional Planning Commission will be attending the March 1, 2010 Board of Trustee meeting to discuss. Bill Lynch stated that he has begun getting calls from residents expressing interest in smaller residential-scale turbines. Joe Clase stated that he will get a copy of LUC's model standards and review them. Jim Lawrenz stated he may be interested in regulating solar panels.
