Members used the LUC Executive Committee recommendation of "Approval with Modification" was used as a discussion template. Members were able to have a very productive question and answer, clarifying discussion regarding each section. Members requested the recommendation letter to be entered to the record to show changes to the final recommended text. The LUC recommended deletions of draft language were executed as well as other sections amended / revised throughout both Article I and Article II.
