### ~ ~ *Upcoming Election* ~ ~

There will be a number of items on the upcoming November ballot. Voting will take place on November 4<sup>th</sup> from 6:30 am to 7:30 pm. Included on this year's ballot is a replacement of the 4.8 mill Millcreek Fire Levy. Millcreek has had the 4.8 millage rate for Fire/EMS for more than a decade. On average there are approximately 40 fire runs and 48 EMS runs in Millcreek Township. For more information about the upcoming Township Fire Levy, please feel free to contact one of the trustees.

The Fairbanks Board of Education voted to place a renewal of the 9.6 mill **Emergency Operating** levy on the November 4, 2008 ballot. The original emergency levy was passed by the voters in 1995, renewed in 2000 and 2004. The costs of general operating expenses has not decreased, while at the same time, inflation, state mandated programs, lower interest rates, rising fuel costs and changes in how schools are funded, all have continued to tighten the school's budget.
