Millcreek Township Trustees Regular Meeting Minutes August 2, 2021

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:55 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from July 6, 2021.

- **Resolution #2191:** motion to approve the minutes of the July 6, 2021 regular meeting by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.

Jerome Township Fire Department

Chief Stewart presented the monthly fire/EMS stats for July and other notable highlights for the department.

- Fire & EMS responses increased year-to-date as compared to the same time a year ago. This was to be expected since prior year responses were down due to COVID-19 restrictions.
- In discussion with Jerome Towship, Jerome Village and Nationwide Realty Investors, a different lot of land was identified for the location of the new fire station near US42. Chief Stewart is working with the Union County Engineer's Office to gain all necessary approvals. Work on designing and planning the new station is somewhat paused for now.
- Nationwide donated equipment and training services to assist with grain bin rescues.
- Shriners International donated a new thermal imaging camera.

Union County Sheriff's Office

Deputy Payton noted that traffic accidents have been increasing in the area recently. Also, thefts and break-ins have increased but most of this activity has been concentrated in Jerome Township. He encourages residents to be mindful about locking their cars when not being used.

Bailey/Renner Lawsuit Against Ohio Department of Agriculture

Thayne Gray, Union County Assistant Prosecuting Attorney, provided the trustees an update regarding lawsuits filed by the Bailey/Renner families against the Ohio Department of Agriculture and Columbia Gas of Ohio. The lawsuits claim the Ohio Department of Agriculture is not enforcing the terms of an agricultural easement against the plans of Columbia Gas to install a natural gas pipeline through the preserved farmland. The lawsuits also seek to stop Columbia Gas from being granted the gas pipeline easements necessary to move forward with installing pipeline through the farmland. Union County Soil & Water Conservation District is also named as part of this legal action.

Zoning

Zoning Commission

Mr. Ron Todd, Zoning Administrator, provided updates to the trustees.

• The Zoning Commission held its regular monthly meeting on July 20th.

• The special public information meetings previously scheduled for early August to present information and answer questions related to the US33 and US42 Corridor Overlay District were canceled. They will be rescheduled at a later time.

Board of Zoning Appeals

Zoning Administrator

Mr. Todd emailed the Zoning Administrator report to the trustees for review prior to the meeting.

- Davisson property follow-up inspection A follow-up inspection for the property at 12140 Watkins Road was completed on July 7th. The follow-up inspection noted some violations identified during the initial inspection were not remedied within the allowable timeframe. The inspection report details were reviewed during the meeting. Discussion amongst Mr. Todd, the trustees and members of the public ensued regarding the violations and what actions were available to remedy the situation. Mr. Thayne Gray believed there is basis to go back to court if the trustees felt this is necessary.
- **Resolution #2192:** motion to authorize Mr. Thayne Gray, Union County Assistant Prosecuting Attorney, to file a Rule to Show Cause in Union County court and incur fees up to \$480 in this matter by Mr. Conroy, seconded by Mr. Long.

- Mr. Todd requested to purchase a new printer for completing his Zoning Administrator duties.
- **Resolution #2193:** motion to purchase a new printer for the Zoning Administrator at a cost not to exceed \$300 by Mr. Conroy, seconded by Mr. Long.

- **Resolution #2194:** motion to accept the Zoning Administrator's report for July 2021 by Mr. Jordan, seconded by Mr. Conroy.
- Motion unanimously approved.

Trustees

Police / Public Safety Officer Services Levy

Mr. Brackenridge filed paperwork with the Board of Elections to place a 2.15 mill replacement levy for police & public safety officer services on the November ballot. The Board of Elections will communicate the official ballot language once finalized.

Enterprise Zone Tax Abatement Claw Back Provision

The Union County Tax Incentive Review Council (TIRC) is scheduled to meet on August 26th. The status of the tax abatement previously granted to Evolution Ag will be reviewed during this meeting. Updates from the TIRC meeting will be reviewed at the next trustee meeting.

Memorandum of Understanding with Union County Soil & Water Conservation District Union County S&WCD is planning to approve the Memorandum of Understanding with Millcreek Township at its next board meeting.

- Mr. Jordan expects to paint the new exterior doors in the near future.

Millcreek Township is eligible to receive funding through the American Rescue Plan Act. Discussion was held amongst the trustees regarding future projects or expenditures that could be completed with the use of these funds.

Heritage Cooperative Propane Prepay Program

Heritage Cooperative is offering a prepay program to lock in the price of propane from October 1, 2021 to April 30, 2022 at \$1.539 per gallon.

- **Resolution #2196:** motion to purchase 1,400 gallons of propane at \$1.539/gallon through Heritage Cooperative's prepay program by Mr. Jordan, seconded by Mr. Long.
