Millcreek Township Trustees Regular Meeting Minutes August 7, 2023

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:20 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from July 10, 2023.

- **Resolution #2380:** motion to approve the minutes of the July 10, 2023 regular meeting by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.

Jerome Township Fire Department

Battalion Chief French discussed the monthly fire/EMS stats for July and other notable highlights for the department.

- EMS responses are lower when compared to this time last year. Fire responses remain about the same as last year.
- Station 211 The new fire station opened in July and is fully operational. New employees hired to fully staff both fire stations are now starting.

Union County Sheriff's Office

Deputy Pitts did not have anything specific to report to the trustees. She took questions from the trustees and anyone else in attendance.

Fairbanks Schools

Adham Schirg, Fairbanks Schools Superintendent, distributed a Master Facility Planning Executive Summary and a Fairbanks Levy FAQ's report to the trustees and discussed the district's facility plans as well as tax levies on the November ballot to fund those facility plans. Mr. Schirg noted several ways in which the school district is planning to disseminate information to residents and engage with people to answer questions about future planning and need for funding. Mr. Schirg then took questions from the trustees and anyone else in attendance.

Zoning

Zoning Commission

The Zoning Commission's regular meeting in July was canceled.

Board of Zoning Appeals

The Board of Zoning Appeals did not meet in July. The Logan-Union-Champaign Regional Planning Commission held a training session in July for Board of Zoning Appeals members. Ron Todd and Jason Comstock attended.

Zoning Administrator

Ron Todd, Zoning Administrator, provided updates to the trustees.

- Mr. Todd will continue sending code enforcement notices as necessary and is following up on a few notices previously sent. Otherwise, not much activity occurred last month.
- The trustees discussed new lighting at the soccer fields near US 42. The trustees may ask the Zoning Commission members to review the Zoning Resolution and

- consider whether any lighting regulations would be beneficial to govern future development.
- **Resolution #2381:** motion to accept the Zoning Administrator's report for July 2023 by Mr. Conroy, seconded by Mr. Jordan.
- Motion unanimously approved.

Jerome/Millcreek Fire Contract Review

Mr. Conroy distributed a draft of the Amended and Restated Fire & EMS Agreement for consideration and approval by the trustees. Mr. Conroy noted all individuals of the contract review committee, including representatives from both townships, accepted the contract as drafted. Highlights of the amended contract include: 1.) contract extension through 2040; 2.) negotiated price increases effective every 5 years (2026, 2031, 2036); 3.) Millcreek Township will contribute up to \$500,000 to Jerome Township for the purchase of a new tanker truck to be owned by Jerome Township; 4.) contract cancelation notice extended to 24 months (from 12 months). The trustees asked questions and noted the contract certainty obtained through this agreement would be positive for residents.

- Garage Electric Electric work inside the garage is mainly complete. The vendor still needs to dig outside the garage and complete the electrical connections.
- Grounds Maintenance Mr. Jordan spread a portion of the new mulch in the playground area and sprayed weeds again a few weeks ago. More work will be done as weather permits.

- Cemetery Software Mr. Long distributed a cost quote from a new vendor to the trustees for review. The new vendor also provided an online demo of their software which Mr. Long will send to the trustees for review. Discussions with vendors will continue.
- Tree Trimming Del-Mar Tree Service completed the tree removal near the township hall since the last meeting. Mr. Long will follow up with the vendor to receive an invoice for the services.
- Fairbanks Master Planning Committee Superintendent Schirg provided an update earlier in this meeting as previously noted.

- 33 Corridor Committee The committee is scheduled to meet next week.
- IT Backup Project / Ongoing Support Mr. Conroy received information for ongoing IT support services from a third-party vendor. He will bring the details for trustee review at the next meeting.
