Millcreek Township Trustees Regular Meeting Minutes December 4, 2023

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:30 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Minutes from the previous trustee meeting held on November 6th were not ready for review and approval. Mr. Brackenridge will have the minutes prepared for review at the next scheduled meeting.

Jerome Township Fire Department

Battalion Chief Billingsley presented the monthly fire/EMS stats for November and other notable highlights for the department.

- Responses continue running slightly below the prior year.
- Fire Marshal Flora has been busy completing inspections. Safety inspections have been increasing, especially with commercial development accelerating in the area.

Union County Sheriff's Office

No representative from the Sheriff's Office attended this meeting.

<u>Zoning</u>

Zoning Commission

Joni Orders, Zoning Commission Chair, emailed an update to the trustees prior to the meeting.

- An information session for the public regarding the US33/US42 Corridor Overlay District was held on November 9th. Aaron Sorrell with Community Planning Insights gave a presentation to residents in attendance and took questions. The Zoning Commission will be open to feedback from residents and the LUC over the next couple of months. Determination on when a public hearing could be scheduled on this topic will be discussed in early 2024.
- The Zoning Commission met on November 21st.
- A public hearing was scheduled for December 13th at 7:00 p.m. to consider updates to the Zoning Resolution regarding Solar Energy projects. The regular monthly meeting of the Zoning Commission was rescheduled to be held directly after this public hearing (normally occurs on the 3rd Tuesday of the month).
- Ms. Orders has been working on administrative edits of the Zoning Resolution and creating a more user-friendly online version.

Board of Zoning Appeals No updates.

Zoning Administrator

Ron Todd, Zoning Administrator, provided updates to the trustees.

- Mr. Todd met with the Union County Recorder to discuss documentation to be filed with the Recorder's Office to ensure Millcreek Township zoning information is complete and up-to-date. Mr. Todd will work with Mr. Brackenridge and the Recorder's Office to move forward with filing any necessary updates.
- Mr. Todd submitted expenses from 2023 for reimbursement.

- **Resolution #2408:** motion to approve reimbursement of expenses to Mr. Todd while fulfilling the role of Zoning Administrator totaling \$482.36 by Mr. Conroy, seconded by Mr. Long.
- Motion unanimously approved.
- **Resolution #2409:** motion to accept the Zoning Administrator's report for November 2023 by Mr. Conroy, seconded by Mr. Long.
- Motion unanimously approved.

<u>Trustees</u>

Building & Grounds Improvement Projects

Mr. Conroy noted the Veteran's sign and surrounding area could be refreshed. The trustees also discussed updating the cemetery shed with new siding and a new metal roof. These updates will be considered further in 2024.

Mr. Jordan

Mr. Jordan was unable to attend this meeting.

Mr. Long

- Cemetery Software Mr. Long distributed a quote and action plan received from Lazarus Cemetery Mapping to implement their cemetery software package. The trustees will review the information and consider it further at a future meeting.
- Tree Trimming Del-Mar Tree Service completed the additional tree trimming around the township hall last month.
- Fairbanks Master Planning Committee One of two tax levies passed during November voting. The school district will consider next steps now that the voting results are complete.

Mr. Conroy

- Pumper Truck Project Mr. Brackenridge will have the first half payment to Jerome Township prepared for the next meeting.
- 33 Corridor Committee The committee's next meeting is scheduled for Friday this week at Fairbanks Schools.
- Mr. Conroy will put up reflectors around the township hall parking lot and cemetery soon.
- Mr. Conroy received information from the State of Ohio regarding the passage of Issue 2 (legalization of marijuana) and limitations permissible at a local government level.

Other Business Items

2024 Budget Planning

Mr. Brackenridge presented the trustees a draft of 2024 appropriations for discussion purposes. The trustees reviewed the draft, asked questions, and provided feedback of some additional expenditures for inclusion. Mr. Brackenridge will incorporate these changes and distribute an updated version to be considered for approval at the year-end meeting.

2024 Organizational Meeting

The trustees scheduled the 2024 organizational meeting on Tuesday, January 2nd starting at 7:00 p.m. at the Millcreek Township Community Building.

Faithful Duty of Performance Insurance Coverage

Mr. Brackenridge presented the trustees information regarding Faithful Duty of Performance insurance coverage in lieu of carrying surety bonds for township officials. This type of insurance coverage was first approved for township's use in 2019 and fulfills the safeguard requirements mandated by the state against employee dishonesty and faithful performance of duty. The information was provided by the township's insurance carrier. To convert to this type of insurance coverage, the township must pass a resolution authorizing the change.

• **Resolution #2410:** motion to authorize Millcreek Township to purchase and use "employee dishonesty and faithful performance of duty policy" through OTARMA instead of individual surety bonds for officers, employees, and

appointees who are otherwise required by law to acquire a bond before entering upon the discharge of duties by Mr. Long, seconded by Mr. Conroy.

• Motion unanimously approved.
