Zoning Commission

The Zoning Commission briefly met on June 21st. The members will continue discussion regarding zoning language or restrictions for solar energy fields with less than 50 megawatts capacity at their July meeting.

Board of Zoning Appeals

The Board of Zoning Appeals met on June 29th to review a variance application. The application requested a side setback reduction for an accessory building for property located at 8869 Watkins Road. The variance application was approved.

Zoning Administrator

Ron Todd, Zoning Administrator, provided updates to the trustees.

- Mr. Todd distributed the 2022 Inspection Report regarding the property at 12140 Watkins Road and reviewed the results with the trustees. The inspection was held on April 20th. Discussion was held regarding the findings and Mr. Todd answered questions from the trustees.

Building & Grounds Improvement Projects

The trustees discussed updating the improvement project list by completing another walkthrough of the buildings and grounds.

- Garage Electric Review The trustees discussed the best timeframe for completing electrical work in the township garage would likely be during the fall 2022. Mr. Jordan will provide this feedback to electrical contractors and seek bids for the trustees to review at a later meeting.
- Playground Weed Control The area was sprayed again recently.
- Township Hall Thermostat The trustees discussed the benefits of having an automated thermostat in the township community building. Issues continue to occur with the current thermostat and its use during rentals and meetings. Mr. Jordan will get further details from an outside vendor.
