Millcreek Township Trustees Regular Meeting Minutes July 5, 2011

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:20 p.m. in the Millcreek Township Community Building for the monthly meeting. Mr. Lynch called the meeting to order with the following members and visitors present:

Business Session

Mr. Lynch asked for a motion to approve the minutes of the regular meeting held on June 6, 2011.

Resolution #1004: motion to approve the minutes of the June 6, 2011 regular meeting by Mr. Lynch seconded by Mr. Jordan.

Sheriff's Report

- Cprl. Warden informed the trustees of the reassignment of Deputy Shawn Waller as a PSO for Millcreek and Jerome Townships.
- The trustees stated they had received complaints about bicycle riders in packs that make it difficult to meet or pass them on roads within the township. Cprl. Warden responded that a bicycle rider is considered as any other vehicle and they should adhere to the same traffic laws as a vehicle. The UCSO can be contacted if residents have a complaint and they will try to contact the group of riders.
- Mr. Jordan noted that the view is obstructed at the corner of Watkins Road and State Road. Cprl. Warden and the trustees will contact the Union County Engineer's Office (UCE).

Jerome Township Fire Department Report

- Chief Skeldon was in attendance for the bi-annual meeting with the trustees. He presented the board with the first half fire/ems runs as well as the monthly report.
- Lt. Wilson made the bi-annual inspection of the Davisson property on Watkins Road.

Zoning

Zoning Administrator

Mr. Clase presented the monthly call and activity log for June.

- **Resolution #1005:** motion to accept the Zoning Administrator's report as submitted for June, 2011 by Mr. Lynch seconded by Mr. Jordan.
- Motion unanimously approved.

Mr. Clase and Mr. Conroy have been compiling information from the Community Survey.

- They will forward pertinent information from the survey to both the UCSO and the UCE.
- Additional information will be posted on the township website.

Mr. Clase visited the Davisson property on Watkins Road on July 5, 2011 and determined the clean-up of the property was approximately 50 percent complete.

• The grinder Mr. Davisson was using needed repairs. Because Mr. Davisson is making progress, he will be given additional time to complete the process.

Mr. Clase noted there is a commercial sign on Watkins Road that is not in compliance with the Zoning Resolution.

• He has sent 2 notices to the property owner but the problem has not been resolved. He will follow up with the Prosecuting Attorney's Office.

Mr. Clase has spoken with the owner of 10761 Watkins Road regarding a new marble/granite business that is operating from the premises in additional to a cabinet shop.

• Mr. Clase informed the owner he would have to apply for a Conditional Use Permit to operated the marble/granite busniness.

Mr. Clase reported the properties on Bellepoint Road and Smart Cole Road that had been issued a nuisanace and nuisance abatement letter have been mowed and the issues are resolved.

Zoning Commission

- Wind turbine language for the Zoning Resolution was discussed at the June meeting.
- The ZC also discussed mowing standards for the township.
- The July ZC meeting has been cancelled.

- The Jerome Village sewer line is being installed on Wells Road and will continue down Bell Road to Harriott Road. The Grilliot property is being used as a holding area for equipment and supplies.
