# Millcreek Township Trustees Regular Meeting Minutes June 6, 2022

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:50 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

#### **Meeting Minutes**

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from May 2, 2022.

- **Resolution #2254:** motion to approve the minutes of the May 2, 2022 regular meeting by Mr. Long, seconded by Mr. Conroy.
- Motion unanimously approved.

# Jerome Township Fire Department

Chief Stewart presented the monthly fire/EMS stats for May and other notable highlights for the department.

- Station 211 Construction is underway. Material and supply chain delays remain a concern.
- Training remains a priority. Two houses were donated for training purposes. An Incident Safety Officer Class was also attended with Marysville.
- The Jerome Township Fire Department will begin offering child car seat installation checks this month.
- Lieutenant David Wilson, a longtime employee of the department with 40+ total years of fire service, is retiring.

## **Union County Sheriff's Office**

Deputy Payton stated there has not been much unusual activity outside of the PSO Officer's normal traffic enforcement efforts in our area. Deputy Payton then took any comments or questions from those in attendance.

### **Public Comment**

Mr. Danny Moore, township resident, sent a proposal to the trustees to provide trimming and weeding services at the township hall grounds and at the cemeteries maintained by the township. The trustees reviewed the proposal and asked questions to Mr. Moore.

- **Resolution #2255:** motion to enter into a contract with Mr. Moore to provide trimming and grounds services at the township hall and at the cemeteries maintained by the township for the period from June 2022 through October 2022 at a rate of \$18 per hour not to exceed a total of \$1,000 for the previously stated period by Mr. Conroy, seconded by Mr. Long.
- Motion unanimously approved.

### **Zoning**

# **Zoning Commission**

Ms. Joni Orders, Zoning Commission Chair, provided updates to the trustees.

- The Zoning Commission held its regular monthly meeting on May 17<sup>th</sup>. The members discussed possible zoning language or restrictions related to solar energy fields with less than 50 megawatts capacity. The LUC provided some boiler plate language as a starting point for members to consider. The Zoning Commission approved holding a public hearing at the township hall to discuss this topic on June 21<sup>st</sup>.
- Discussion has begun again with Aaron Sorrell from Community Planning Insights regarding the US33 and US42 Corridor Overlay District language.

### **Board of Zoning Appeals**

No updates.

### **Zoning Administrator**

Mr. Ron Todd, Zoning Administrator, was unable to attend this meeting. Mr. Todd emailed the monthly zoning activity report to the trustees for review prior to the meeting.

- **Resolution #2256:** motion to accept the Zoning Administrator's report for May 2022 by Mr. Conroy, seconded by Mr. Long.
- Motion unanimously approved.

Mr. Conroy provided an update related to the hearing held in Union County Court in May. The judge ruled the property owner at 12140 Watkins Road, Marysville, Ohio, was in contempt of the court's previous judgment and ruled in favor of Millcreek Township in regards to the Motion for an Order to Show Cause. The property owner has a limited time to comply with the terms of the previous judgment; otherwise, the judge's sentence will be imposed.

#### **Trustees**

### November 2022 Fire Levy

Mr. Brackenridge shared draft language to consider placing a fire & EMS levy on the November 2022 ballot.

- Resolution #2257: motion for a resolution declaring the necessity for a 4.8 mills fire and emergency services replacement levy and requesting the county auditor certify current valuation and revenues by Mr. Long, seconded by Mr. Conroy.
- Motion unanimously approved.

Mr. Brackenridge will follow-up with the County Auditor to receive the required certification and will then distribute draft language for a resolution to proceed.

### State Capital Budget Funding (Garage Improvements)

The State's overall capital budget was approved recently. Our submission for improvements to the garage was not approved.

## **Building & Grounds Improvement Projects**

The trustees will consider scheduling another walkthrough of the buildings and grounds in the near future.

### Mr. Jordan

Mr. Jordan was unable to attend this meeting.

- Garage Gutters & Soffit Repair Received two estimates for repairs to the garage gutters and soffit. Mr. Long will follow-up with those vendors to get more information regarding the estimates. A third quote may be received as well.
- The leak in the township hall roof was repaired since the last meeting.

- Mr. Conroy is getting new estimates from vendors for replacement garage doors.
