Millcreek Township Trustees Regular Meeting Minutes March 7, 2022

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:00 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from February 7, 2022.

- **Resolution #2230:** motion to approve the minutes of the February 7, 2022 regular meeting by Mr. Jordan, seconded by Mr. Conroy.
- Motion unanimously approved.

Jerome Township Fire Department

Chief Stewart was not able to attend the meeting but he emailed the monthly stats for February to the trustees prior to the meeting. Chief Stewart also communicated that the groundbreaking ceremony for the new fire station will likely be scheduled for late March or early April.

Union County Sheriff's Office

Deputy Payton noted their continued traffic enforcement efforts in our area. He also commented on an uptick in thefts of packages and catalytic converters. Deputy Payton then took any comments or questions from those in attendance.

Public Comment

Union County Commissioners Christiane Schmenk and Dave Burke highlighted several topics impacting Union County, including various economic developments as well as discussion regarding solar farms in the county. Both spoke about how they are trying to manage the growth within Marysville and the rest of the county. Commissioner Schmenk also spoke about her campaign for re-election, noting her experience for the position and areas of focus for her during her second term if re-elected.

Zoning

Zoning Commission

The Zoning Commission held its regular monthly meeting on February 15th. Members held further discussion and moved closer toward voting on finalized language regarding:

- Drainage plan/pond requirements and review by The Union County Soil & Water Conservation District.
- Development of a community tree program per Land Use Growth Plan goals.
- US33 Innovation and US 42 Corridor Overlay Districts language.

Final drafts could be reviewed and voted on at next month's meeting.

Board of Zoning Appeals

The Board of Zoning Appeals held its 2022 organization meeting on February 2nd. A listing of Conditional Use Permits was reviewed and updated where necessary.

Zoning Administrator

Ron Todd, Zoning Administrator, provided updates to the trustees.

- A court date was set for March 18th by the Union County Court of Common Pleas. The hearing will review the matter brought forth in the Motion for an Order to Show Cause due to violations of a previous judgment for activities occurring at 12140 Watkins Road, Marysville, Ohio.
- Follow-up communication will be monitored regarding a violation letter sent to a property on Smart Cole Road related to operating a commercial business.

- Ron will coordinate getting the updated zoning map signed by each of the trustees at a later meeting.
- **Resolution #2231:** motion to accept the Zoning Administrator's report for February 2022 by Mr. Jordan, seconded by Mr. Conroy.

State Capital Budget Funding (Garage Improvements)

Mr. Conroy submitted the state capital funding request for improvements to the township garage by the February deadline.

Building & Grounds Improvement Projects

Mr. Jordan will work to clear the ballfield areas that have stone and hard materials when the weather and ground conditions improve.

Mr. Conroy

- Gas Line Projects Project timelines are delayed due to pending lawsuits related to the projects.
- 33 Corridor Committee The Committee met on February 11th. Mr. Conroy will highlight notable items that impact our area at a later meeting.
- The Union County Engineer's Office Annual Meeting is being held on March 19th.
- Mr. Conroy noted the interest by local residents in the meeting held by the Union County Commissioners in February to discuss solar farms. Mr. Conroy appreciated the Commissioners flexibility in accommodating the large gathering of people and many differing opinions were shared at the meeting.
