### Millcreek Township Trustees Regular Meeting Minutes May 3, 2021

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:05 p.m. to 9:05 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

### **Meeting Minutes**

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from April 5, 2021.

- **Resolution #2168:** motion to approve the minutes of the April 5, 2021 meeting by Mr. Long, seconded by Mr. Jordan.
- Motion unanimously approved.

## Jerome Township Fire Department

Lieutenant Eric Billingsley presented the monthly fire/EMS stats for April and other notable highlights for the department.

- Fire & EMS responses were comparable to this time last year. No noteworthy activity.
- Work on the design of a new fire station near US42 is now beginning. IAP Government Services Group, acting as a third-party construction administrator, is requesting quotes for architectural services and will assist in finalizing a contract with the selected architecture firm.

### **Union County Sheriff's Office**

Sheriff Jamie Patton presented the Sheriff's Office 2020 Annual Report and the Sheriff's Office 2020 Annual Township Report for Millcreek and Jerome Townships.

- Sheriff Patton discussed call activity and statistics highlighting the Sheriff's Office workload during 2020 as well as some notable achievements of his team.
- Deputy Alex Wargo will be a newly assigned Public Safety Officer in 2021 to Millcreek and Jerome townships.
- Discussion was held with Sheriff Patton, Chief Deputy Tom Morgan and the Millcreek Township Trustees regarding a new Public Safety Services contract beginning in 2022. The current contract expires at the end of 2021. Chief Deputy Morgan will provide estimated costs for those services prior to the next meeting.

## Northern Columbus Loop Gas Pipeline Project

Thayne Gray, Union County Assistant Prosecuting Attorney, updated the trustees on the Northern Columbus Loop Gas Pipeline Project. A public hearing was held last week. Mr. Gray presented to the trustees a Joint Stipulation and Recommendation that would resolve all issues identified by the Ohio Power Siting Board and Columbia Gas. Mr. Gray asked the trustees for authorization to sign on behalf of Millcreek Township to join as a party to the Joint Stipulation and Recommendation.

- **Resolution #2169:** motion to authorize Mr. Thayne Gray, Union County Assistant Prosecuting Attorney, to sign on behalf of Millcreek Township Board of Trustees to enter into the Joint Stipulation and Recommendation as presented at this meeting by Mr. Jordan, seconded by Mr. Long.
- Mr. Conroy abstain; Mr. Jordan yes; Mr. Long yes

## Enterprise Zone Tax Abatement

Mr. Gray also took questions from the trustees regarding the tax abatement status in effect with Evolution AG. There is a tax incentive agreement with Evolution AG for its business operating within Millcreek Township. The tax incentive requires certain job and investment thresholds be met. The trustees asked questions to Mr. Gray about what steps

could be taken if Evolution AG is not meeting these thresholds and if any taxes could be received as part of the claw back provision in the agreement. More information is needed. Follow-up will occur with the Tax Incentive Review Council.

## Union County Soil & Water Conservation District ("UCSWCD")

The trustees discussed the benefits and drawbacks of entering into a Memorandum of Understanding with UCSWCD regarding the review and coordination of adequate drainage, proposed pond sites and other soil/water considerations. This would only be for residential, not commercial.

- **Resolution #2170:** motion to enter into a Memorandum of Understanding with Union County Soil & Water Conservation District for mutually agreed services and responsibilities for soil and water considerations by Mr. Conroy, seconded by Mr. Jordan.
- Motion unanimously approved.

Zoning Commission

Ms. Joni Orders, Zoning Commission Chair, provided updates to the trustees.

- The Zoning Commission held its regular monthly meeting on April 20<sup>th</sup>.
- Draft language for the overlay district (US33 and US42 Corridor) was reviewed in detail. Suggested changes will be sent to our consultant for review with the intent to get his feedback by the next meeting.
