Millcreek Township Trustees Regular Meeting Minutes November 1, 2021

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 9:00 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from October 4, 2021.

- **Resolution #2212:** motion to approve the minutes of the October 4, 2021 regular meeting by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.

Jerome Township Fire Department

Battalion Chief Adams attended to answer any questions the trustees might have or provide information for notable items happening within the fire department.

- Chief Stewart will email the monthly fire/EMS stats for October to the trustees at a later time.
- Meetings continue this week to discuss preparations for the new fire station (Station 211) near US42. They hope to go out to bid later this month.

Union County Sheriff's Office

Deputy Payton attended to answer any questions the trustees might have.

- Deputy Payton noted an increase in OVI's recently in the area. However, most of this enforcement occurred within Jerome Township rather than impacting Millcreek Township.
- Deputy Payton and the trustees discussed how the new traffic lights at US33 & US42 appear to have helped traffic flow at that intersection.

Public Comment

Tracy Richardson, our State Representative for the 86th District, spoke to gain feedback from the trustees regarding any issues or priorities they were currently working on for our area as well as to provide some information to the trustees regarding projects she was working on at the Statehouse. Tracy is working on several statewide and local projects. She encouraged the trustees or anyone to reach out to her with questions/concerns and provided her contact information.

Zoning

Zoning Commission

No meeting was held in October because there were not enough members present for a quorum. Administrative items were discussed on zoning agendas.

Board of Zoning Appeals

The Board of Zoning Appeals met on October 13th to consider a variance request for a proposed lot split for the property located at 10334 Long Road. The variance application was denied.

Zoning Administrator

Mr. Ron Todd, Zoning Administrator, was unable to attend this meeting. Mr. Todd emailed the monthly zoning activity report to the trustees for review prior to the meeting. The report provided updates on approved permits, code enforcement activities and other miscellaneous activity.

Trustees

Public Safety Officer (PSO) Replacement Levy

A 2.15 mill replacement levy for police & public safety officer services is on the November 2nd ballot for Millcreek Township. Union County Sheriff Jamie Patton and Chief Deputy Tom Morgan attended an informational meeting for the public on October 14th held at the Millcreek Township Community Building to discuss the PSO Program. Residents were able to ask questions and gain additional feedback.

TIRC Enterprise Zone Tax Abatement

The Union County Tax Incentive Review Council (TIRC) will follow-up with the trustees later in November with more information regarding its recommendation to cancel the tax abatement with Evolution Ag. The Millcreek Township trustees will plan to discuss this topic further at the December meeting.

Mr. Jordan

- Mill Creek Log Jam Project An article was published in the Marysville Journal Tribune last month discussing this project. It remains unclear how the work to clear the log jams will be funded.
- Trails & Greenway Committee The next meeting is scheduled for Tuesday, November 16th.
- The new thermostat for the township community building has been installed.

Mr. Long

- New locks for the garage and exterior township doors were installed.
- Union County Housing Task Force Committee No update.
- Fire Station Design Committee No update.

Mr. Conroy

- A quote to replace fencing around the playground was received. This quote will be considered at a later time as part of the 2022 budgeting process.
- Bunsold Excavating completed their work last month to improve drainage near the township playground and adjoining property.
- 33 Corridor Committee No update.
- Mr. Conroy participated as part of a group including representatives from Jerome Township and the Union County Sheriff's Office to discuss a new contract for PSO services. The existing contract expires on December 31, 2021. Topics such as the contract length, shift coverage and Fire & EMS training for PSO officers was discussed. A request was also made to consider the completion of a long-term personnel study for the Sheriff's Office. More meetings will be held in November working towards drafting a contract the trustees can consider at their next scheduled meeting.
- Mr. Conroy noted that funding could be available through the state's capital budget process to make improvements to the township garage, including pouring a concrete floor in the garage. This would assist being a backup for holding Fire, EMS and Police equipment. The trustees will follow-up with vendors to get more information regarding cost estimates.

Other Business Items
