Millcreek Township Trustees Regular Meeting Minutes October 2, 2023

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:25 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from September 5, 2023.

- **Resolution #2392:** motion to approve the minutes of the September 5, 2023, regular meeting by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.

Jerome Township Fire Department

Chief Stewart discussed the monthly fire/EMS stats for September and other notable highlights for the department.

- EMS and fire responses through September are lower when compared to this time last year.
- Specs for the new tanker truck were approved by the trustees of Millcreek and Jerome Townships. The tanker truck has been ordered. In addition, a new Medic Unit is on track to be delivered in April 2024.

Union County Sheriff's Office

Deputy Werling did not have anything specific to report to the trustees. He took questions from the trustees and anyone else in attendance.

Mill Creek Log Jam Project

Jeff Stauch, Union County Engineer, presented an overview of the county's plans to remove log jams in Mill Creek as well as maintaining the creek in the future to improve stormwater drainage and the related infrastructure as well as improve access to clean drinking water. The Board of County Commissioners set aside funds from the State and Local Fiscal Recovery Fund to pay for the engineering and construction costs to clear and restore the creek. Mr. Stauch requested the trustees of Millcreek Township to consider a resolution to petition the Board of County Commissioners to remove obstructions from Mill Creek. The trustees asked questions of Mr. Stauch and Mr. Gray.

- Resolution #2393: motion to approve a petition to remove obstructions from Mill Creek and submit the petition to the Board of County Commissioners, Union County, Ohio, as well as approve the Union County Drainage Improvement Petitition Bond in the amount of \$63,080 which will be encumbered in the Township's General Fund until called or released by Mr. Jordan, seconded by Mr. Long.

Public Comment

Shawn Sech, Director of Health Promotion & Planning for the Union County Health Department, passed out information from the Union County Drug Free Coalition regarding marijuana use and its impact. She also highlighted a couple of initiatives that are either on the November ballot (State Issue 2, recreational use) or are being considered in the Ohio Senate (Senate Bill 9, revisions to medical use).

Zoning

Zoning Commission

Joni Orders, Zoning Commission Chair, provided updates to the trustees.

- The Zoning Commission met on September 19th.
- The Commission discussed the US33/US42 Corridor Overlay District language.
 The members are ready to schedule an information session for the public
 regarding the Overlay District. Ms. Orders requested the trustees approve
 nominal funding for mailing costs to send notifications to township residents in
 the Overlay District area.
 - Resolution #2394: motion to approve costs of preparing and mailing notifications to be sent to residents in the overlay district area regarding an information session to learn about the US33/US42 Corridor Overlay District.

Board of Zoning Appeals

Zoning Administrator

Ron Todd, Zoning Administrator, provided updates to the trustees.

- Second letters sent to property owners regarding inoperable vehicle violations. Mr. Todd will follow up as necessary.
- Permit activity has been light recently.
- **Resolution #2395:** motion to accept the Zoning Administrator's reports for August and September 2023 by Mr. Jordan, seconded by Mr. Long.

Trustees

Mr. Jordan

- Garage Electric The contractor still has work to complete in order to finish this project. No specific timeframe is scheduled yet.
- Grounds Maintenance A new emergency light for the front of the building is on order.
- Mr. Jordan attended the Union County Township Association meeting last month and noted some highlights for the trustees.

Mr. Long

- Cemetery Software Information sharing has occurred with two vendors. Mr. Long will continue researching which option is best.
- Fairbanks Master Planning Committee Initial construction in the elementary school is set to begin. As noted previously, Fairbanks Schools will have two tax levies for consideration on the November ballot.

Mr. Conroy

- 33 Corridor Committee The next committee meeting is scheduled to occur in a couple of weeks.
- The porta johns have been removed from the ballfield for the winter season.
- Mr. Conroy is looking into including a link to the Union County Sheriff's Office career job postings board on our website.

Other Business Items

Certification of Rates and Amounts for Tax Levies

Mr. Brackenridge presented the trustees with the certification of rates and amounts received from the Union County Auditor's Office.

- **Resolution #2396:** motion to accept the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor by Mr. Conroy, seconded by Mr. Long.

Heritage Cooperative Propane Prepay Program

Heritage Cooperative is offering a prepay program to lock in the price of propane from October 1, 2023 to April 30, 2024 at \$1.599 per gallon.

- **Resolution #2397:** motion to purchase 1,800 gallons of propane at \$1.599/gallon through Heritage Cooperative's prepay program by Mr. Long, seconded by Mr. Jordan.
