Millcreek Township Trustees Regular Meeting Minutes September 3, 2024

The Millcreek Township Trustees of Union County, Ohio convened in regular session from 7:00 p.m. to 8:30 p.m. at the Millcreek Township Community Building for the monthly meeting. Mr. Conroy called the meeting to order with the following members present:

Meeting Minutes

Mr. Conroy asked for a motion to approve the regular monthly meeting minutes from August 5, 2024.

- **Resolution #2496:** motion to approve the minutes of the August 5, 2024 regular meeting by Mr. Jordan, seconded by Mr. Long.
- Motion unanimously approved.

Jerome Township Fire Department

Battalion Chief Billingsley presented the monthly fire/EMS stats for August and other notable highlights for the department.

- Responses continue running higher than last year, with most of the increase coming from runs within Jerome Township or Mutual Aid. Training hours completed by department personnel have increased as well. The number of inspections, specifically commercial, has increased with added staff in this area.
- The new Medic Unit is still projected to be put into service in September.

Union County Sheriff's Office

No representative from the Sheriff's Office was able to attend this meeting.

Public Comment

A question was asked regarding any expansion plans for the soccer fields near Watkins Road and beyond to Brown Road. The trustees discussed current zoning restrictions in place there.

A question was asked regarding the accumulation of asphalt grindings on a property near the intersection of US 42 and Smart Cole Road.

Zoning

Zoning Commission

Joni Orders, Zoning Commission Chair, provided an update to the trustees.

- The Zoning Commission met in August. Representatives from PLANNING Next attended that meeting and provided a progress update and additional information regarding the review of the township's Comprehensive Land Use Growth Plan and Zoning Resolution. This topic will continue to be discussed during the Commission's next meeting in September.
- Discussion regarding the US33/US42 Overlay District is planned for the September meeting as well.

Board of Zoning Appeals

No updates

Zoning Administrator

Ron Todd, Zoning Administrator, was unable to attend tonight's meeting but did email the monthly Zoning Administrator's report to the trustees prior to the meeting for review.

- Motion unanimously approved.

Trustees

The Union County Commissioners scheduled a public hearing on September 10th at 6:30 p.m. The hearing will cover information regarding the proposed project to clear logiams within Mill Creek and plan for ongoing maintenance. It is planned that real estate owners of property within the watershed area will be assessed fees for ongoing maintenance.

Building & Grounds Improvement Projects

The trustees will update the list of building and grounds improvement projects based on the review completed during a special meeting earlier today.

Mr. Jordan

Spraying of weeds throughout the township grounds and playground will continue throughout the fall season. All other projects were previously discussed during the building and grounds inspection earlier today.

Mr. Long

- Township Hall Landscaping & Cemetery Shed Projects Completion of the landscaping project around the township hall and maintenance on the cemetery shed should be completed over the next month.
- Cemetery Software Third party vendor inputting data into the new software system. They will continue updating the system for a planned go-live over the next few months.
- Township Hall Tables & Chairs Replacement The tables and chairs are ready and are being held by the furniture company. Delivery will be dependent on the timing of the flooring installation.

Mr. Conroy

- PSO Contract Representatives from Millcreek Township, Jerome Township and the Union County Sheriff's Office met to discuss details of a new PSO contract starting January 1st, 2025. Length of the contract, cost, and the possibility of eliminating the requirement for PSO officers to have added Fire & EMT training were some of the key points discussed. Further discussions will be held in order for a final contract to be drafted and voted on by each party involved.
- Tornado Sirens The option to have sirens installed which operate by solar power with a battery backup was discussed in more detail. The purchase of tornado sirens will be discussed further at next month's meeting when Chief Stewart should be able to attend.
- .gov Domain Migration Grant Information gathering and the grant application are in process (the State of Ohio is accepting grant applications to help subsidize the cost for governmental entities to transition domain registrations to ".gov").
- County Electric & Gas Aggregation Proposal The Union County Commissioners placed an initiative on the November 5th ballot to allow Union County to aggregate electricity and natural gas purchases in order to secure price discounts. There will be no fee to opt-out of the aggregation program if it is approved. Residents are encouraged to learn more about the ballot initiative.

Other Business Items

Certification of Rates and Amounts for Tax Levies

Mr. Brackenridge presented the trustees with the certification of rates and amounts received from the Union County Auditor's Office.

- **Resolution #2498:** motion to accept the rates and amounts as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor by Mr. Conroy, seconded by Mr. Long.
