**CALL TO ORDER:** Meeting and public hearing called to order by Zoning Commission Chair Joni Orders at 7:10 p.m.

**RECOMMENDATION OF THE LOGAN-UNION-CHAMPAIGN REGIONAL PLANNING COMMISSION:** Joe Clase stated that the Regional Planning Commission (RPC) recommended denial of the amendments on December 12, 2014 and presented a copy of their staff report and justification.

**ZONING ADMINISTRATOR'S COMMENTS:** Joe Clase presented the text amendments addressing items listed in the LUC report, primarily indicating:

- Grammatical changes appear appropriate;
- It will be hard to define best management practices (BMP) but recommending them can allow the Board of Zoning Appeals some flexibility during site plan review:
- Removing the training requirements appears consistent with prior board concerns; and
- Neighbor consent appears to be unprecedented.

**PUBLIC COMMENTS:** Keith Conroy (10181 Watkins Road) stated that he liked the idea of removing the training based on the RPC's recommendation. The BMPs are not required by the state, so it would be nice to see the township being able to review and make recommendations to an applicant in this regard. He stated that he would work with the Environmental Protection Agency (EPA) to get better feedback on

what they require for fuel stations prior to adoption of fuel station standards.

Keith & Debbie Rausch (13482 Industrial Parkway) inquired of the definition of fuel station and stated that there should be greater standards for larger commercial outfits. It was clarified that agricultural fuelling stations would be exempt unless they commercially sold the fuel outside of their agricultural operations.

**BOARD DISCUSSION:** The board reviewed the draft fuel station standards and made the following notations:

- 1. Definition A definition for fuel station needs to be added to be comprehensive of other terms and they should be amended throughout the code as necessary to be uniform.
- 2. The second paragraph should be amended with the following changes. "Will" should read "may." "Gasoline" should read "fuel." "Hereby" should read "therefore." The phrase "by storm water" should be removed, along with "and any other land use that is likely to contaminate groundwater."
- 3. The third paragraph should include language regarding approval "per plan" and that whichever regulation is greater shall be enforced.
- 4. Section 10510(C) regarding training shall be removed.
- 5. Section 10530(A) should be revised to require "notification" versus "consent" from neighbors within 1,000 feet.

Keith Conroy stated that he would like the opportunity to seek further feedback from his contacts with the Ohio Environmental Protection Agency.
